

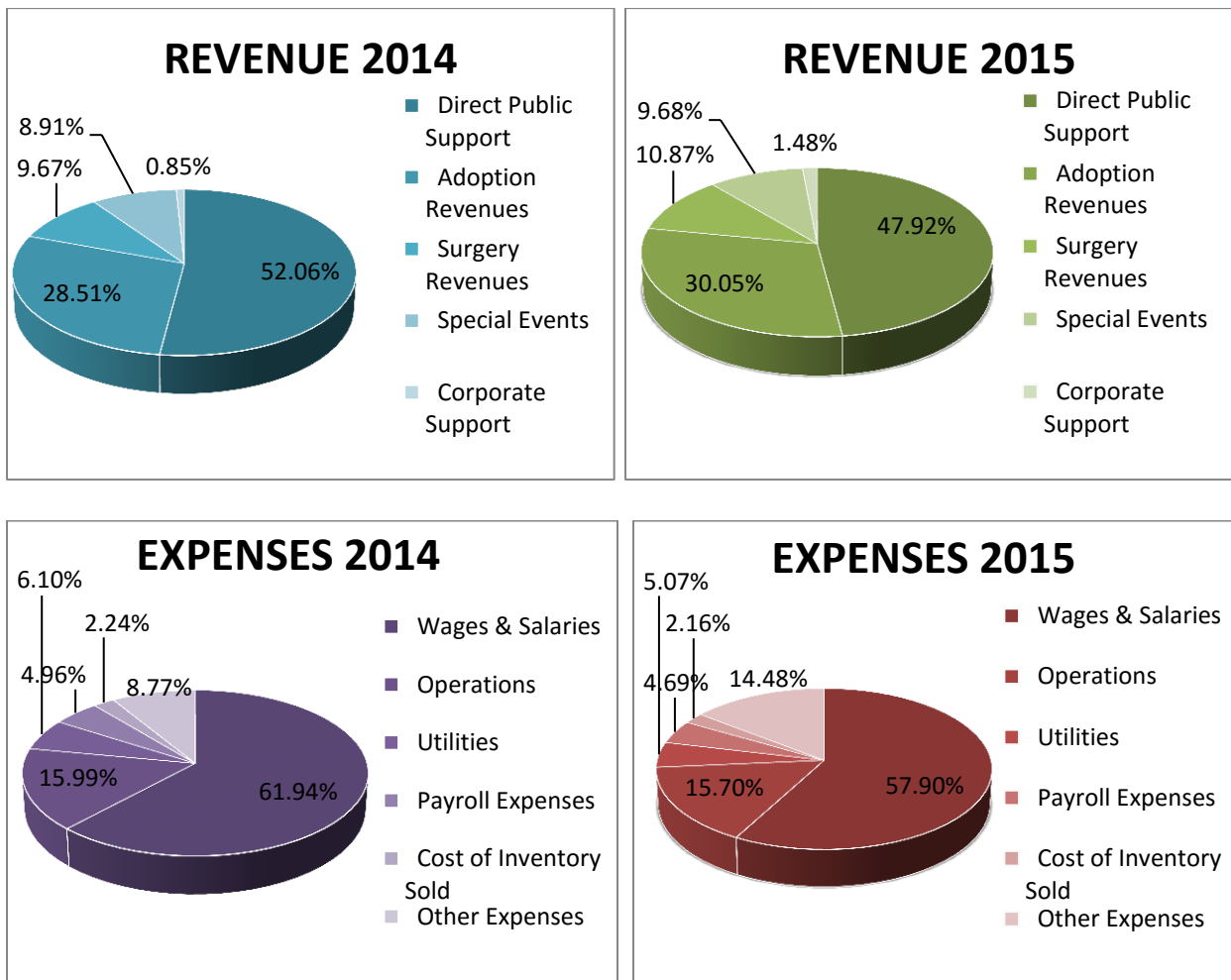
Your Donations at Work

Privacy Policy

Thank you for visiting the St. Francis Community Animal Rescue and Education (St. Francis CARE) website and reviewing our Privacy Policy. St. Francis CARE created this Privacy Policy to explain what information we collect, why we collect it and how we will protect your personal privacy within our website. The following discloses our information gathering and dissemination practices for the website located at the URL <http://www.stfrancis-care.org>.

Our Privacy Policy is clear: when you visit our website, we will collect no personal information about you unless you provide it to us.

What Information We Collect

Our volunteer and adoption forms require users to give us contact information that may include name, e-mail address, address, interests, and similar information. We do not request or store sensitive information from our visitors, such as credit card or social security numbers.

St. Francis CARE does not collect any personally identifiable information about you unless you voluntarily submit such information to us. This information is used solely by St. Francis CARE for internal purposes.

Donor Privacy

Priority is given to safeguarding donor confidentiality. St. Francis CARE does not sell, trade, rent, or otherwise make available personal donor information, nor send mailings on behalf of other organizations. This policy applies to all information received by St. Francis CARE, both online and offline, as well as any electronic, written, or oral communication. St. Francis CARE does occasionally acknowledge supporters by gift range. If supporters prefer to remain anonymous they can inform St. Francis CARE of their desire to have their name withheld from supporter lists.

Use of Information

St. Francis CARE respects your privacy and has instituted policies intended to ensure your personal information is handled in a safe and responsible manner. We may use this information to deliver to you information about St. Francis CARE, as well as for trend analysis, pattern detection, and website administration.

We will only disclose personally identifiable information to third parties when (i) the person submitting the information authorizes us to do so; (ii) sharing the information is a necessary operation of the website (i.e. to process credit card information); and (iii) we are required to do so by law or in the good-faith belief that such action is necessary to (a) conform to the edicts of the law or comply with legal process served on St. Francis CARE or the website; (b) protect and defend the rights or property of St. Francis CARE, the website or the visitors to the website, and/or (c) act under exigent circumstances to protect the personal safety of visitors to the website or the public.

St. Francis CARE mandates no donor information can be sold or shared. By visiting this website you agree that no information you submit to the website shall contain libelous or otherwise unlawful, abusive, or obscene material. You are solely responsible for the content of any information you provide to St. Francis CARE.

Unfortunately, however, no data transmission over the Internet is 100% secure. While we strive to protect your information, we cannot ensure or warrant the security of such information.
